Public Inspection Requirement

THE HOUSES ARE LOCATED NEAR LURIE CHILDREN'S HOSPITAL, UNIVERSITY OF CHICAGO COMER CHILDREN'S HOSPITAL, LOYOLA UNIVERSITY MEDICAL CENTER, ADVOCATE CHILDREN'S HOSPITAL AND NORTHWESTERN MEDICINE CENTRAL DUPAGE HOSPITAL. THE FAMILY ROOMS ARE LOCATED INSIDE EDWARD HOSPITAL, LURIE CHILDREN'S AND UNIVERSITY OF CHICAGO COMER CHILDREN'S HOSPITAL.
